

The Model PTVS1-380C-TH high voltage, bidirectional TVS diodes are designed for use in AC line and high power DC bus clamping applications.

The devices are RoHS* compliant. They also meet IEC 61000-4-5 8/20 μs current surge requirements.















Typical V_{BR} vs. Junction Temperature




